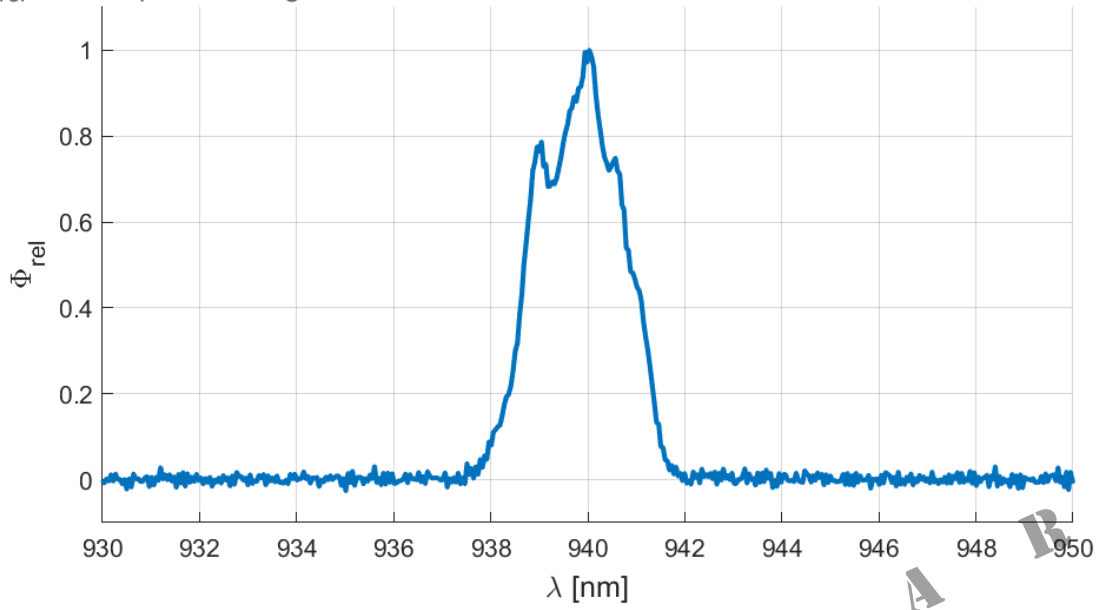

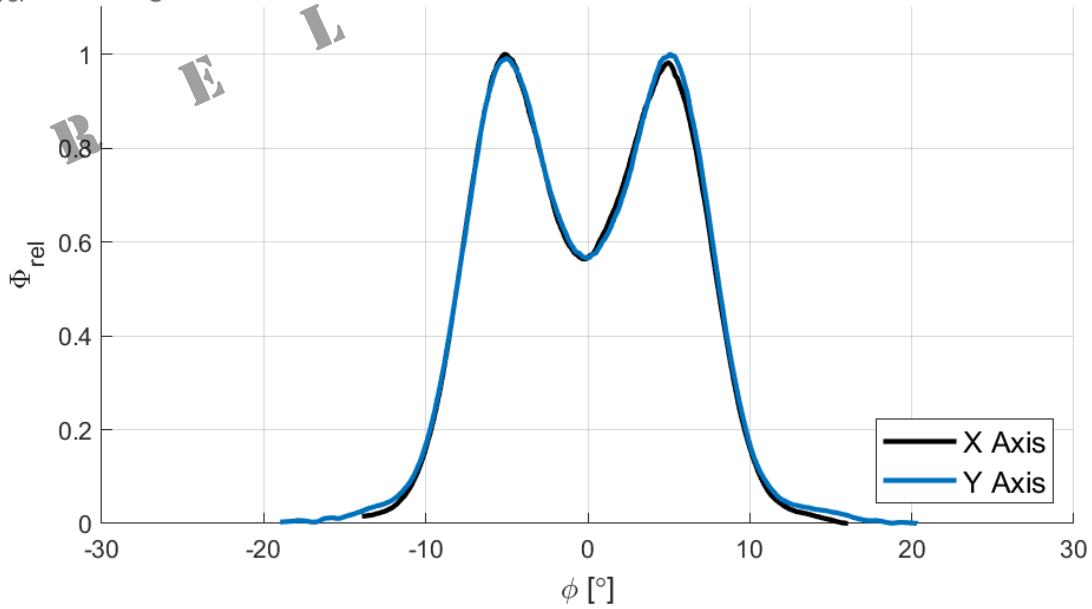

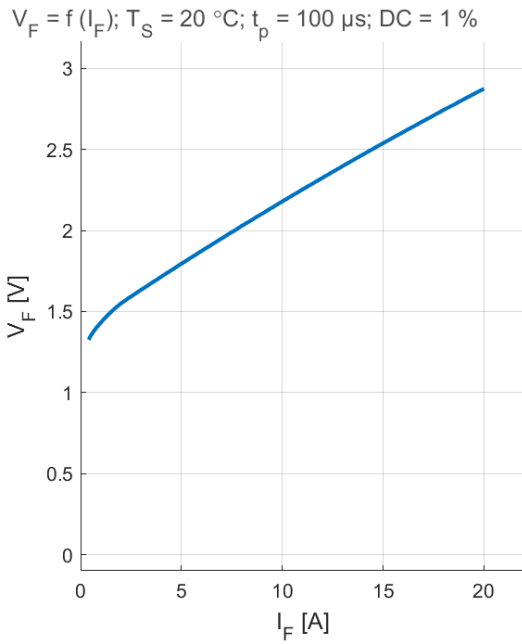


**Radiation Characteristics <sup>1)</sup>**

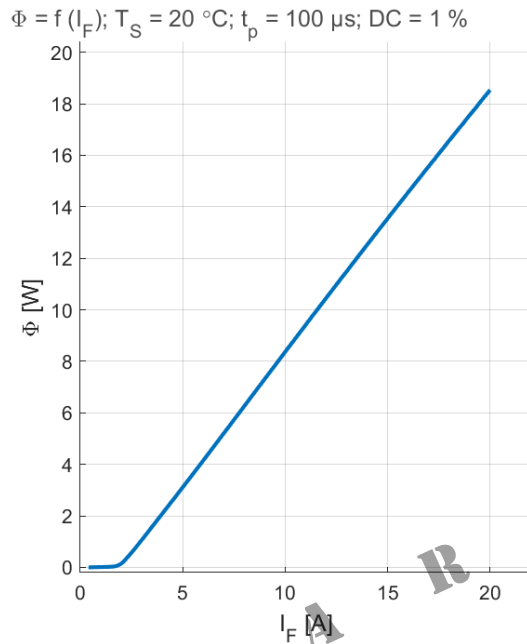

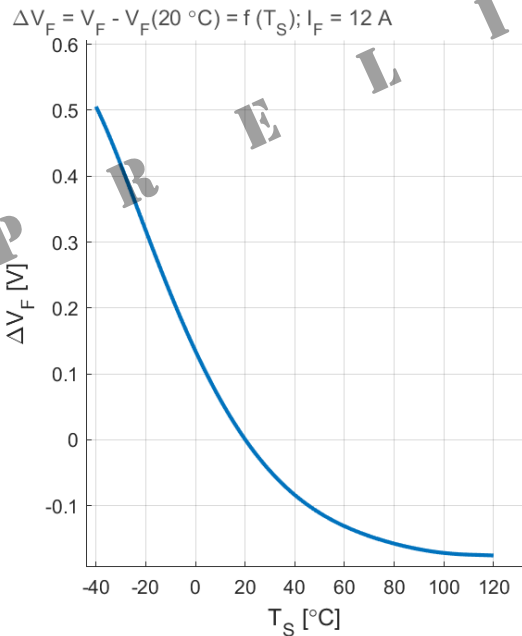
**Forward Voltage <sup>1) 2)</sup>**



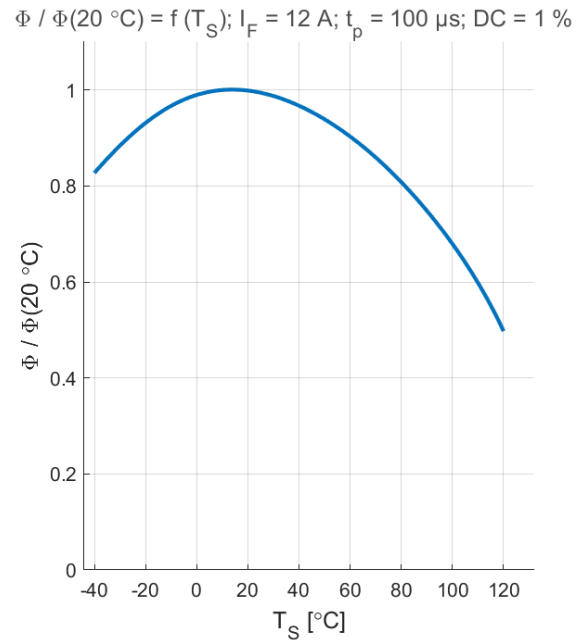
**Optical Output Power <sup>1) 2)</sup>**



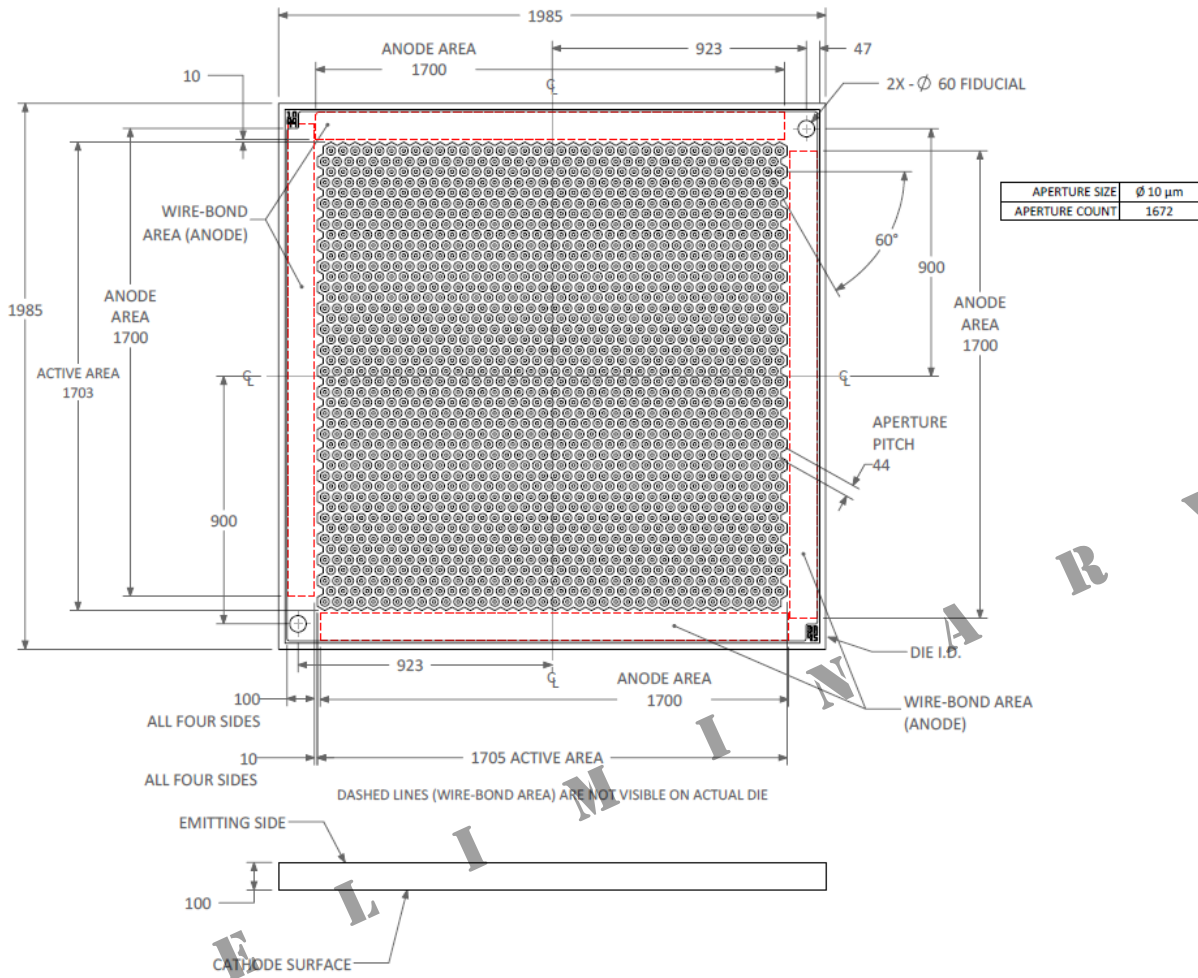
**Relative Forward Voltage <sup>1)</sup>**

## Notes
