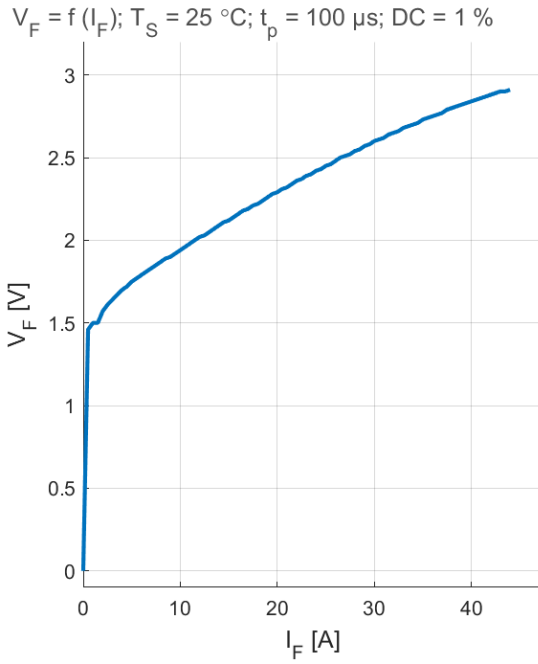

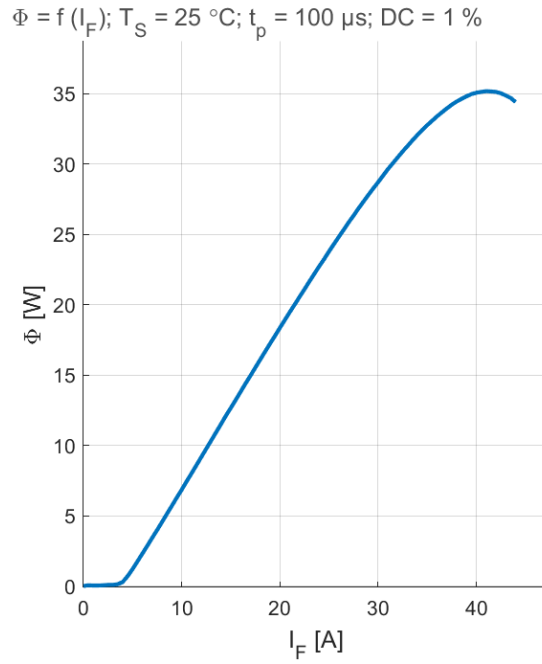

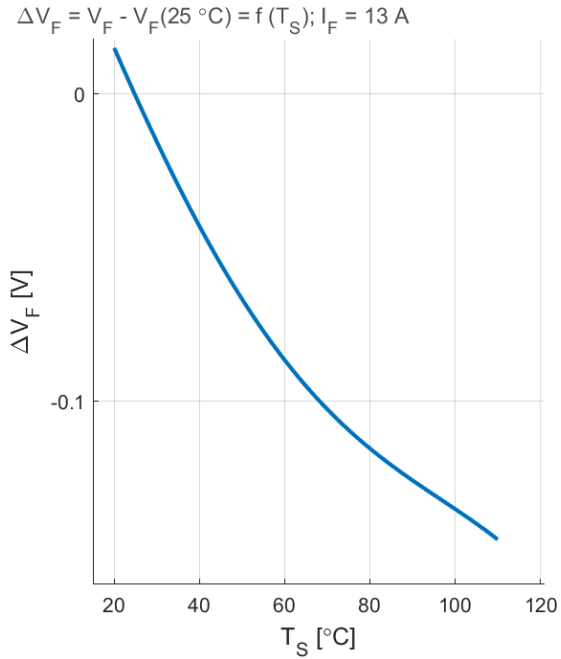
**Forward Voltage <sup>1) 2)</sup>**



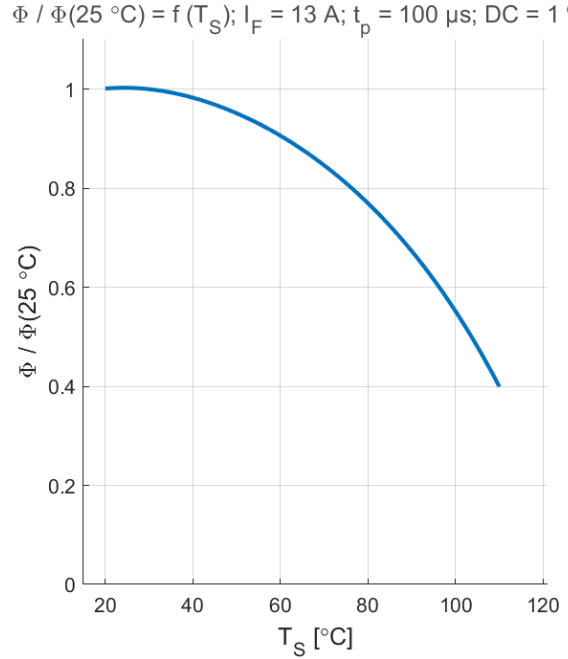
**Optical Output Power <sup>1) 2)</sup>**



**Relative Forward Voltage <sup>1)</sup>**

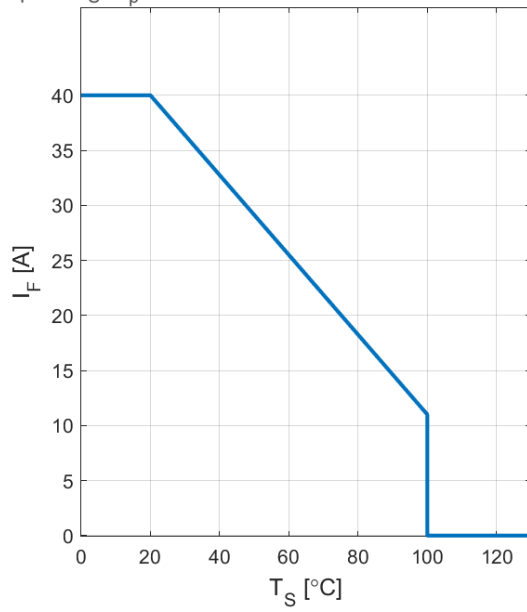


**Relative Radiant Power <sup>1)</sup>**

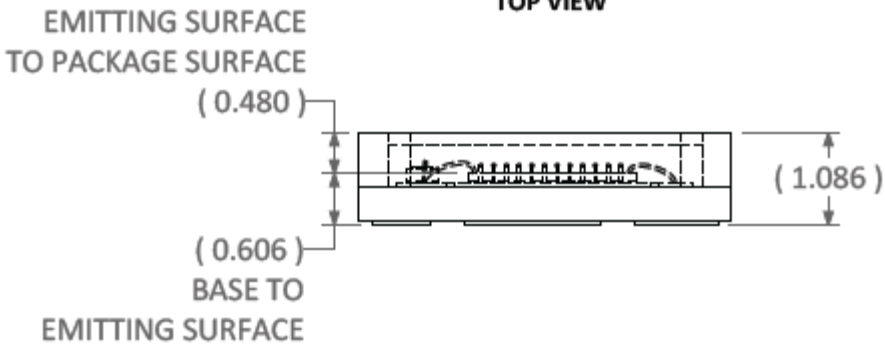
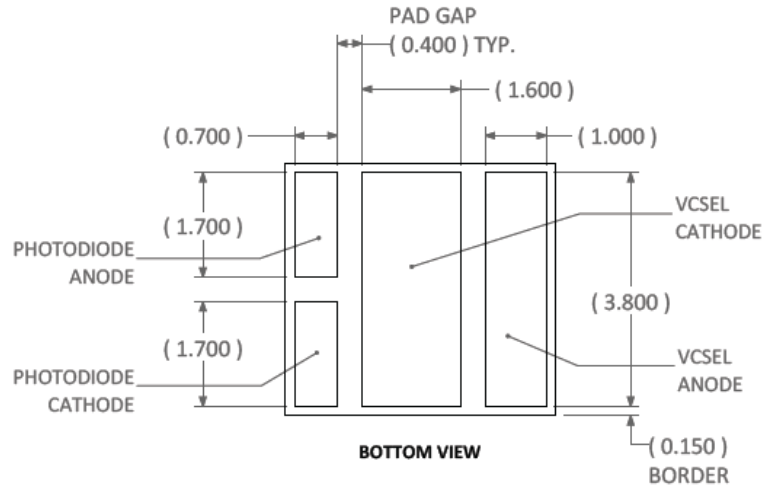
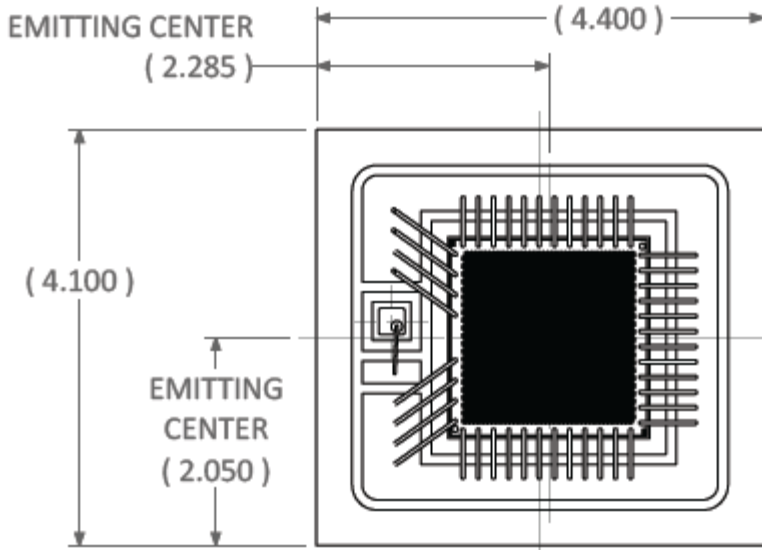


## Max Permissible Pulse Current

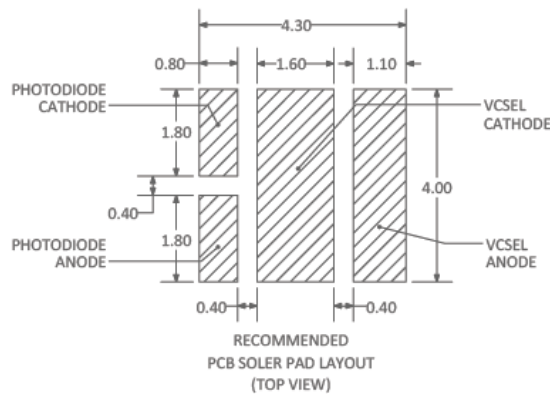

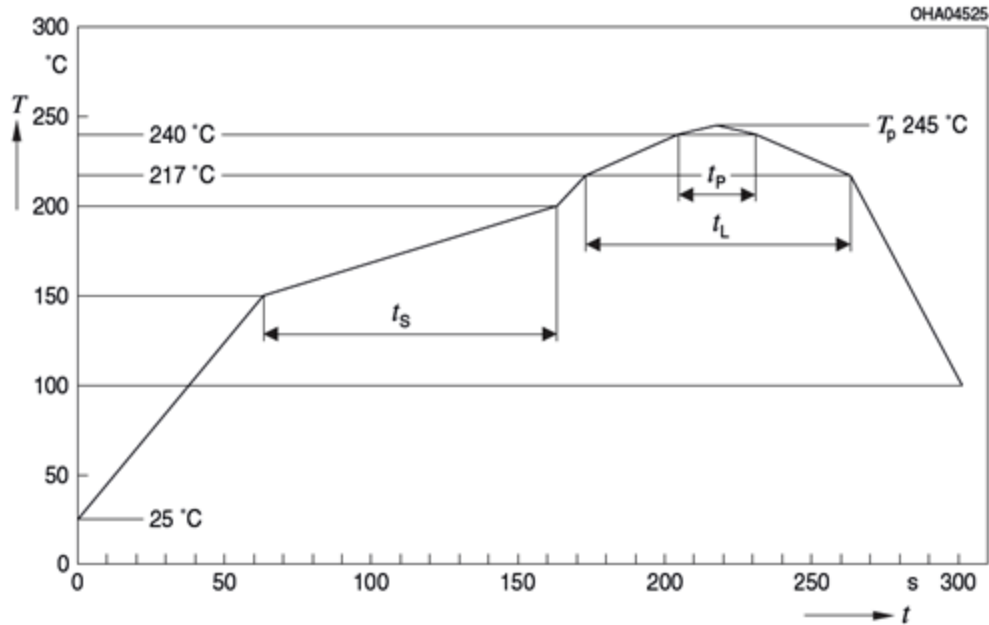
